

A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD IN THE CITY OF ORANGE, TEXAS, ON THE 3RD DAY OF MAY, 2025.

WHEREAS, there was held in the City of Orange, Texas, on the 3rd day of May, 2025, a General Election at which were submitted to the duly qualified resident electors of said City the following candidates for city offices; and it was found after being officially canvassed that the votes were cast as follows, to-wit

WHEREAS, a total of 595 ballots were cast in said election; and

WHEREAS, Brad Childs received a majority of the votes for Place 2 (Single-Member District 2), Mary McKenna received a majority of the votes for Place 4 (Single-Member District 4) and George Mortimer received a majority of the votes for Place 5 (At-Large); and;

WHEREAS, said election was duly called and notice thereof given in accordance with law; only duly qualified resident electors of said City voted at said election; the election was held in the manner required by law; returns of the election have been canvassed by the City Council of the City of Orange, Texas; now therefore

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORANGE, TEXAS:

I.


That a majority of voters elected Brad Childs as Council Member for Place 2 (Single-Member District 2), Mary McKenna as Council Member for Place 4 (Single-Member District 4) and George Mortimer as Council Member for Place 5 (At-Large).

II.

That it appears to the City Council that Brad Childs, Mary McKenna and George Mortimer are qualified under the Charter of the City of Orange, Texas to hold office and hereby declared to be ELECTED to such office.

In the event any provision of this election Resolution is inconsistent with provisions of the Texas Election Code pertaining to municipal actions, or incomplete, the provisions of the Election Code of the State of Texas shall apply.
